Dear Stakeholder:

Many Island Pipe Line (Canada) Limited (MIPL), a federally regulated and wholly owned subsidiary of SaskEnergy Incorporated, a Saskatchewan Crown Corporation, is providing updated information on the Pierceland Supply project (previously referred to as Cold Lake Receipt Expansion Project).

MIPL is proposing to build an approximately 30 kilometer natural gas pipeline from the Nova Gas Transmission Limited (Nova) meter station east of Cherry Grove, AB to the TransGas Limited (TransGas) meter station east of Beacon Hill, SK. Additionally, a new compressor station is proposed to be constructed near the west end of this gas pipeline, within Saskatchewan.

Keeping our stakeholders informed is an important aspect of all of our projects. Accordingly, we wish to advise you that MIPL submitted a supplementary filing to the National Energy Board (NEB), now the Canada Energy Regulator (CER), on February 3, 2020. For your reference, the CER brochure *A Proposed Pipeline or Power Line Project:* what you need to know and a map showing updated proposed pipeline route have been included with this letter. The application material includes details of MIPL consultation with potentially affected parties. It also includes information from MIPL regarding any potential impacts the project may have on Indigenous interests, and any measures proposed by MIPL to address project-specific impacts.

Where a proposed project may potentially affect the interests or rights of Indigenous peoples, the CER requires companies to begin consultation activities early in the planning of a proposed project. This early consultation is aimed at both understanding how a project may affect Indigenous interests or rights and ways to mitigate any potential impacts. If the project is approved, company consultation must continue throughout construction, operation and abandonment phases.

This letter is being sent to you as Notice of the Application. If you have concerns about a proposed project, the CER strongly encourages you to contact the company first to have those concerns considered.
