Dear Sir/Madam:

RE: Pierceland Supply Project – Supplemental Filing #2

Many Islands Pipe Lines (Canada) Limited (MIPL), a federally regulated and wholly owned subsidiary of SaskEnergy Incorporated, a Saskatchewan Crown Corporation, is providing updated information on the Pierceland Supply project (previously referred to as Cold Lake Receipt Expansion Project).

MIPL is proposing to build an approximately 30-kilometer natural gas pipeline from the Nova Gas Transmission Limited (Nova) meter station east of Cherry Grove, AB to the TransGas Limited (TransGas) meter station east of Beacon Hill, SK. Additionally, a new compressor station is proposed to be constructed near the west end of this gas pipeline, within Saskatchewan.

Keeping potentially affected parties informed is an important aspect of all of our projects. Accordingly we advise that:
