Many Islands Pipe Lines (Canada) Limited (MIPL(C)L)

MIPL(C)L is a federally regulated and wholly owned subsidiary of SaskEnergy Incorporated, a Saskatchewan Crown Corporation, and is providing updated information on the Pierceland Supply project (previously referred to as Cold Lake Receipt Expansion Project).

MIPL(C)L is proposing to build an approximately 30-kilometer natural gas pipeline from the Nova Gas Transmission Limited meter station east of Cherry Grove, AB to the TransGas Limited meter station east of Beacon Hill, SK. Additionally, a new compressor station is proposed to be constructed near the west end of this gas pipeline, within Saskatchewan.

Keeping potentially affected parties informed is an important aspect of all of our projects. Accordingly, we advise that on May 29, 2020 MIPL filed supplemental information to the Canada Energy Regulator (CER) including updated schedule, material specification and project economics information, updated land acquisition and engagement status information, and a corrected design drawing, illustrating the correct demarcation of the project work.
