Re: A99944 Many Islands Pipe Lines (Canada) Limited – Pierceland Supply Project Many Islands Pipe Lines (Canada) Limited (MIPL(C)L)

MIPL(C)L is a federally regulated and wholly owned subsidiary of SaskEnergy Incorporated, a Saskatchewan Crown Corporation, and is providing updated information on the Pierceland Supply project (previously referred to as Cold Lake Receipt Expansion Project).

MIPL(C)L is proposing to build an approximately 30-kilometer natural gas pipeline from the Nova Gas Transmission Limited meter station east of Cherry Grove, AB to the TransGas Limited meter station east of Beacon Hill, SK. Additionally, a new compressor station is proposed to be constructed near the west end of this gas pipeline, within Saskatchewan.

Keeping potentially affected parties informed is an important aspect of all of our projects. Accordingly, we advise that on May 29, 2020 MIPL filed a supplemental information letter to the Canada Energy Regulator (CER) identifying a staging area for the storage and preparation of pipe, equipment storage and maintenance, and to accommodate office trailers in support of construction operations.
